END-USER LICENSE AGREEMENT FOR GraphoLearn (<VERSION_INFO>, "SOFTWARE PRODUCT")

IMPORTANT, PLEASE READ THE TERMS AND CONDITIONS OF THIS LICENSE AGREEMENT CAREFULLY BEFORE CONTINUING TO USE THIS PROGRAM:

UNIVERSITY OF JYVÄSKYLÄ's End-User License Agreement ("EULA") is a legal agreement between you (either an individual or a single entity) and UNIVERSITY OF JYVÄSKYLÄ for the UNIVERSITY OF JYVÄSKYLÄ software product(s) identified above which may include associated software components, media, printed materials, and "online" or electronic documentation ("SOFTWARE PRODUCT"). By installing, copying, or otherwise using the SOFTWARE PRODUCT, you agree to be bound by the terms of this EULA.

This license agreement represents the entire agreement concerning the program between you and UNIVERSITY OF JYVÄSKYLÄ, (referred to as "LICENSOR"), and it supersedes any prior proposal, representation, or understanding between the parties. If you do not agree to the terms of this EULA, do not install or use the SOFTWARE PRODUCT.

The SOFTWARE PRODUCT is protected by copyright laws and international copyright treaties, as well as other intellectual property laws and treaties. The SOFTWARE PRODUCT is licensed, not sold.

1. GRANT OF LICENSE.

The SOFTWARE PRODUCT is licensed as follows:

(a) Installation and Use.

LICENSOR grants you the right to install and use copies of the SOFTWARE PRODUCT on officially supported platforms.

(b) Backup Copies.

You may also make copies of the SOFTWARE PRODUCT as may be necessary for backup and archival purposes.

2. DESCRIPTION OF OTHER RIGHTS AND LIMITATIONS.

(a) Maintenance of Copyright Notices.

You must not remove or alter any copyright notices on any and all copies of the SOFTWARE PRODUCT.

(b) Distribution.

You may not distribute copies of the SOFTWARE PRODUCT to third parties without explicit permission from LICENSOR.

(c) Usage

You may not use the SOFTWARE PRODUCT commercially without prior written consent from LICENSOR. You must have explicit permission from the legal guardians of any minors that use the SOFTWARE PRODUCT under your supervision.

(d) Prohibition on Reverse Engineering, Decompilation, and Disassembly.

You may not reverse engineer, decompile, or disassemble the SOFTWARE PRODUCT, except and only to the extent that such activity is expressly permitted by applicable law notwithstanding this limitation.

(e) Rental.

You may not rent, lease, or lend the SOFTWARE PRODUCT.

(f) Support Services.

LICENSOR may provide you with support services related to the SOFTWARE PRODUCT ("Support Services"). Any supplemental software code provided to you as part of the Support Services shall be considered part of the SOFTWARE PRODUCT and subject to the terms and conditions of this EULA.

(g) Compliance with Applicable Laws.

You must comply with all applicable laws regarding use of the SOFTWARE PRODUCT.

3. TERMINATION AND CHANGES

(a) Without prejudice to any other rights, LICENSOR may terminate this EULA if you fail to comply with the terms and conditions of this EULA. In such event, you must destroy all copies of the SOFTWARE PRODUCT in your possession.

You may terminate this EULA by ceasing to your use of GraphoLearn.

(b) University of Jyväskylä may in our discretion make any change to these Terms without notice to you. You are responsible for reviewing the revised Terms and/or any applicable postings.

You accept any changes to this EULA if you continue to use the GraphoLearn after you have been explicitly informed of any update (e.g., at the start of the application). If you do not accept the proposed changes, this EULA terminates and you cannot continue use GraphoLearn.

We may change GraphoLearn, add or delete any features or functionality, or any aspect of the services, in any way at any time for any reason.

4. COPYRIGHT

All title, including but not limited to copyrights, in and to the SOFTWARE PRODUCT and any copies thereof are owned by LICENSOR or its suppliers. All title and intellectual property rights in and to the content which may be accessed through use of the SOFTWARE PRODUCT is the property of the respective content owner and may be protected by applicable copyright or other intellectual property laws and treaties. This EULA grants you no rights to use such content. All rights not expressly granted are reserved by LICENSOR.

5. NO WARRANTIES

LICENSOR expressly disclaims any warranty for the SOFTWARE PRODUCT. The SOFTWARE PRODUCT is provided 'As Is' without any express or implied warranty of any kind, including but not limited to any warranties of merchantability, noninfringement, or fitness of a particular purpose. LICENSOR does not warrant or assume responsibility for the accuracy or completeness of any information, text, graphics, links or other items contained within the SOFTWARE PRODUCT. LICENSOR makes no warranties respecting any harm that may be caused by the transmission of a computer virus, worm, time bomb, logic bomb, or other such computer program. LICENSOR further expressly disclaims any warranty or representation to Authorized Users or to any third party.

6. LIMITATION OF LIABILITY

You expressly understand that in no event shall LICENSOR be liable for any damages (including, without limitation, lost profits, business interruption, or lost information) rising out of 'Authorized Users' use of or inability to use the SOFTWARE PRODUCT, even if LICENSOR has been advised of the possibility of such damages. In no event will LICENSOR be liable for loss of data or for indirect, special, incidental, consequential (including lost profit), or other damages based in contract, tort or otherwise. LICENSOR shall have no liability with respect to the content of the SOFTWARE PRODUCT or any part thereof, including but not limited to errors or omissions contained therein, libel, infringements of rights of publicity, privacy, trademark rights, business interruption, personal injury, loss of privacy, moral rights or the disclosure of confidential information.

The terms of this EULA and your relationship with University of Jyväskylä under these Terms shall be governed by the laws of the State of Finland without regard to its conflict of laws provisions.
